Rendie advised we just started our new fiscal year and nothing has been spent yet and the carry over balance is \$290,000.

UTRGV CLINIC AGREEMENT – Consideration and possible action regarding the Revised Performance Agreement between the LV CDC and the UTRGV clinic. (General Manager)

Rendie advised the committee of the approved changes in the agreement including changing the hours slightly to include one evening opening and one weekend day opening to allow more access to the clinic as well as being present at Town events. UTRGV's changes are asking for increased assistance not to exceed \$125,000 annually. Discussion of the agreement regarding the large increase in assistance was had and the outcome was no action pending further instruction and research from the City manager.

PARKS MASTER PLAN – Public Hearing, Consideration and possible action with regard to the funding of the Parks Master Plan and Development of the TPWD proposal for the Town of Laguna Vista (General Manager)

The Proposal was brought to Committee back in July and the application was approved for \$20,000 this goes to pay for the creation of the Parks Master Plan and the creation and development of the TPWD local Park Grant program. Patty Alexander comes highly recommended; she has written Grants and park proposals for a lot of the surrounding areas and even has done work in Laguna Vista for the Eco Tourism Center's early stages.
