FINANCIAL REPORTS - Review of Monthly Financial Reports. (City Manager)

City Manager Rendie advised that the Reconciliation General Fund city balance as per the book is at \$2,781,005.79. Statement revenue and expenditures, we are at approximately 43% collected for our projected revenue, this time last year we were at 40% so we are ahead 3% from last year. Our expenditures the city is at 7% this year at this time last year we were at 6%. We are right on track. Council Member Howard questions about check numbers 34438 & 34458 for cleaning services and why the difference in amount. Clarification was made that pay is for both City Hall and Library and the difference was for event hours help.

PROCLAMATION - Monarch Butterfly Proclamation/ Pledge for the 2024/2025 fiscal year.

Rendie explains what the Monarch Butterfly Proclamation is about and how important it is to our community, it's a pledge that we as a city, pledge every year.

Mayer Carter reads the Proclamation to everyone.

ENGINEERING SERVICES TASK ORDER REGARDING LAGUNA VISTA FIRE DEPARTMENT EXPANSION — Discussion and possible action approving Guzman & Munoz Engineering & Surveying Task Order No. P962-04 for the development and professional services related to the Laguna Vista Fire Department Building Expansion. (City Manager & City Engineer).

Rendie advised that the extension of the fire department to add an additional bay that will house an ambulance a couple days a week from Los Fresnos, in addition it will house the donated food truck for the Salvation Army. The City has reached out to the city engineers for the bid of \$28,500 for the project, which will include, Topical Survey, Systematic Site Design, Floor Design, Permits, 100% construction documents, and Construction Phase Oversite.

RESOLUTION NO. 2024-15 — Discussion, consideration and possible action to approve Resolution 2024-15 Town Council of the Town of Laguna Vista authorizing the City Manager to enter into an agreement with Laguna Vista Police Department, to utilize a portion of the Town of Laguna Vista American Rescue Plan Funds. (City Manager).

Rendie advises that the ARPA fund has increased to \$197,131 for the use of the Police building and to use a portion of the rescue plan funds. Mayor Carter explains that it is Covid money that was given by the government for Covid Relief and that it has to be designated because we are running out of time.

PLAN REVIEW OF LAGUNA VISTA POLICE DEPARTMENT – Discussion and Consideration of the Laguna Vista Police Department Building. (City Manager & City Engineer).

Rendie advised that on the screen is the proposal layout for the Police Department Building and let Ms. Sara Orta with Guzman & Munoz Engineering Firm explain the layout. Ms. Orta explains the new Police department building is a layout of 3,049 sq ft design that will have storage locker, designated restrooms, 2 vehicle garage and is going to be a metal building with brick layout designed to it with a safety privacy fence for vehicles and police officer safety. The layout of the building will be slightly changed, including parking. Darla Jones questions dispatch and Jail. Mayor answers no, because its contemplated in the future to move to a bigger facility on Hwy 100. On a side note, Council was informed that Guzman & Munoz have experience in designing Raymondville's Police Department as a reference.

RATIFICATION- 2024/2025 EMS CONTRACT — discussion and possible action to ratify the 2024/2025 EMS contract with Los Fresnos ambulance regarding. (City Manager).

Rendie explains that this is the contract that EMS made with the City of Los Fresnos. She states it has been approved with the budget. Los Fresnos has provided us with the written agreement and it just needs to be ratified. It has been passed by Mr. Ozuna.

NASBLA BOAT OPERATION AND TRAINING — Discussion and possible action regarding NASBLA Boat Operation Training(Council Hernandez & Mayor Carter).

Mayor Carter explains that it is a training to get our police department better trained in the use of the boat we have, since in recent years we have been more active on shallow waters. Chief Anthony David then explains that this is a very high training field and further advises it is more for an instance of a terrorist ship that come in pursuit that schools on how a boat can chase another boat. No decision has been made towards this Training and will need more information until approval is granted. Chief David advised council that Game Warden will give a class free of charge.

RESOLUTION 2024-14- Discuss, consider, and adopt a resolution authorizing the submission of a Texas Community Development Block Grant Program to the Texas Department Of Agriculture for the 2025/2026 Community Development Fund. (City Manager).

Rendie explains that policies for the CDBG Grant have changed for the next fiscal year of 2025-2026 cycle which the city will need to re-submit to gain access to these funds for future or on-going projects. CDBG also have other programs open for use for smaller businesses to use and will need to be submitted by the 20th of November.

2025 TOWN CELEBRATION DATES- Consideration and possible action to determine the date of the 2025 Town Events.(City Manager).

Rendie explains to Council that an email was received from the pyrotechnics regarding the date for the 4th of July event that needs to be decided pretty quickly to lock in the date. The whole year events were basically planned to present to council to be decided on as well. Independence Day Celebration, in discussion over the fireworks show to either be cancelled or held next year due to rising prices of fireworks which has increased 6% over the last year which increases the amount to \$18,000, no decision has been made yet. Fall Festival in consideration to change the weekday that it will be held instead of Friday to be held on Saturday, it has been approved for October 25th 2025. Memorial day will be on May 26th,2025, Veteran's Day is to be held on the same day as last year, no change has been made. (November 11th 2025). Christmas Event/ Winter Wonderland to be held on the same day as last year Dec 12th,2025. Easter Color Run to be held on April 12th, 2025.
